



Statement of Financial Support and Form I-20

Please read the instructions and requirements carefully before submitting your financial documents.

What is a Form I-20?

The Certificate of Eligibility Form I-20 is a U.S. government form that Iowa Central uses to certify that you are eligible for F-1 student status. You need an I-20 to obtain an F-1 student visa and to keep lawful F-1 status when transferring or changing schools in the U.S.

What documents do I need to submit to get an I-20?

- Statement of Financial Support
- Bank statement showing a minimum of \$20,575 USD
- Valid Passport
- Proof of High School Graduation

What are the Financial Support Document Requirements?

You must submit an official, original bank statement issued directly by the bank. The statement must meet the following criteria:

- indicate the financial institution's name
- indicate the account holder's name
- clearly show the account balance
- be dated within the past 3 months (older statements will not be accepted)
- be translated into English (especially names) unofficial translations are accepted
- clearly show the type of currency
- be from statements that show liquid assets that can be converted to cash
- showing bank/financial statements from multiple accounts is acceptable

IMPORTANT: The following types of funding are NOT accepted:

- Documents older than 3 months
- Income or salary statements
- Funds that are not immediately accessible
- Assets that are not in liquidated form (house, car, etc.)
- Life insurance policy statements
- Pension funds
- Tax return forms
- Statements from a Business Account

Scanned copies of original documents must be clear and in color. Screen shots of accounts are not accepted.

What is a Sponsor?

- If the funding is under someone else's name (ex: parent, family member, friend), then they are considered your sponsor. You may have more than one sponsor.
- Each Sponsor must complete the *Sponsor Section* of the Statement of Financial Support and include a copy of Passport or legal ID.
